Terms for Campground Participation Agreement

In exchange for the services provided by MHC Resort Parks Limited Partnership ("RPI"), _____ ("Campground") agrees to host RPI members, on a space available basis, for the discounted rate(s) listed above. The Campground further agrees to, in general, afford RPI members the same rights and privileges offered its regular customers. The Campground may change amount of the discount(s) upon not less than 60 days' notice to RPI. However, any reservations made prior to the change shall be honored.

RPI will provide the Campground with a campground listing on RPI's website (www.resortparks.com), at no charge, as well as periodically featuring the Campground in RPI's newsletter. The Campground is responsible for providing RPI with accurate information for its listing, including updated photos of the Campground. The Campground represents to RPI that it has the right to use all information and photos provided to RPI.

The Campground agrees to dedicate at least one RV site that RPI may reserve for RPI members up from two to 60 days in advance without first confirming availability with the Campground. For other reservations, RPI will confirm availability with the Campground in advance. RPI will provide the Campground with an email confirmation of all reservations as well as make an internet portal available for the Campground to check the status of reservations.

The term of this Agreement will commence on the date set forth above and continue on a month-to-month basis until terminated by either party on not less than 120 days' written notice to the other party. The Campground agrees to honor all reservations made prior to termination. Notices to RPI must be in writing and emailed to mail@resortparks.com. Notices to the Campground will be sent to the email address set forth above.

This agreement shall be governed by the laws of the state of California, and venue for any action at law or in equity pursuant to this agreement shall be in Los Angeles County, California.
